### **Wisconsin Coalition of Independent Living Centers (WCILC)**

Wisconsin Independent Living Centers Coalition Network Council

I'd like to take a moment to introduce myself. My name is Jason Glozier and I am the Director of the Wisconsin Coalition of Independent Living Centers. When Kyle asked me to write something for their newsletter, I was incredibly excited for the opportunity. It's not often I get to come out from behind the curtain to talk about what the Coalition does and who I am.

I took over as Director of the Coalition at the beginning of 2022 and am starting my third year in this role. This marked my return to the Independent Living Movement after being away for more than a decade, and I am excited to be back. In my previous job, I served as the Disability Rights and Services Specialist for the City of Madison. In that role I was responsible for ensuring accessibility in all city programs and services, which allowed me to develop a broad base of expertise. What really brought me back to IL and the Disability Rights Movement was how little I could really impact within a government system. The big issue that made me return was the longstanding home care crisis and a realization that our communities need leadership to hold government accountable for this issue. In my role at the City I often found myself biting my tongue on issues I couldn't impact, now I hope to be a voice, and help people find there voice.

The Coalition is made up of leadership from all 8 centers, and is a vehicle for their collective action and representation across the state. I often get asked how the Coalition relates to the general community and I think this is best demonstrated through our advocacy groups. Although most of my work happens at the State level it begins with you. Many of you have received our advocacy priorities survey over the years, and this helps to set the agenda for my advocacy priorities. In addition, part of my role is providing technical assistance to the ILCs in Wisconsin and ensure that their staff are equipped to provide the best services possible. Over the past two years we have focused on strengthening best practice efforts and statewide consistency in hopes that all people in Wisconsin get the same level of services regardless of where they live. It is my hope that as you work with your local ILC you keep in mind that you can impact things at a statewide level by sharing your concerns and needs. This upcoming year we will be looking at ways to better include the public in advocacy efforts, and hope you will be interested in joining us.

Devin's main goal for the future is to be happy and make others happy too! His biggest mission is sharing awareness that living with Autism makes him Different not less.










## **Caregiver Highlight**

## **Assistive Technology Corner**



### **Assistive Technology Demonstration & Loan Program**

WisTech is Wisconsin's Assistive Technology (AT) program. AT is a device or service that allows people to function as independently as possible at home, school, work, and in the community. CILWW is a regional AT Device and Demonstration Center. CILWW has almost 2,000 different AT devices that we can loan and/or demonstrate to people. CILWW staff can bring devices to people's homes, answer questions about devices, loan devices for a short period of time, give vendor and funding resources, and use their experience to help find the most cost effective options.

### Check out our new assistive technology devices!

#### **Foot Flush for Toilets**

Simple daily tasks that many people take for granted can become difficult for the elderly or persons with disabilities. Many individuals struggle with dexterity, reach range, balance, and physical barriers that prevent them from doing daily tasks. One prominent barrier for individuals can be toileting, it is a necessity, but can become an overwhelming task. One piece of assistive technology that may ease the barrier of flushing is the Foot Flush. The Foot Flush is a hands free flushing device for toilets. This device is designed for those experiencing barriers from arthritis, pain, reach range, and physical barriers. It is easy to install and works on most standard toilets. The handle of the toilet will still work if the foot flush is installed.

If you would like more information on Foot Flush or any other assistive technology devices that could potentially improve your independence, please call CILWW at 715-233-1070 or 800-228-3287. CILWW provides services at no cost to the individual, and are not a funding source to purchase the assistive technology.

There are various services available through the Assistive Technology program at CILWW. As a part of the WisTech Assistive Technology Program our agency can provide information on WisTech's alternative financing options (WisLoan, Telework, and TEPP) per request.



## **AT Programs and Services**

### Are you or someone you know...



- Hard of hearing?
- · Deaf or severely hard of hearing?

If you answered yes, you may be interested in finding the AT you need to access telephone services. Equipment could be amplified phones, captioning phones, neck loops, and other devices. Schedule an appointment to try a variety of equipment with one-on-one assistance from knowledgeable and experienced staff!

## **TEPP**

Staff can also help you apply for funding through TEPP: Telecommunications Equipment Purchase Program. Money collected through WI telephone service providers goes into the WI Universal Service Fund, which pays for TEPP. CILWW's role is to help you access the funding you need to get the equipment you need!



### **Loan Programs**

**WisLoan** offers loans to help people buy assistive technology or equipment such as modified vehicles, wheelchairs, and ramps. There are no income requirements and individuals are not required to exhaust personal or public funding. Under the program, banks provide loans at a fixed interest rate of 6.5% to qualified borrowers. Loan amounts depend on the item and ability to repay.

**Telework** is a loan program that allows residents with disabilities to purchase computers and other equipment needed to work from home or from other remote sites away from the office, such as work on the road or at a Telework center.
